A RESOLUTION CALLING FOR A PUBLIC HEARING TO HEAR PUBLIC INPUT ON ACCEPTING ROADS, AS DESCRIBED HERIN, TO BE A PUBLIC ROAD

WHEREAS, the statues of the State of Montana vest in the Board of County Commissioners with authority and responsibility regarding roads and bridges, and such statutes are generally found in Montana Code Annotated Title 7, Chapter 14, and;

WHEREAS, the Roosevelt County Commissioners are aware that the following roads exists in Roosevelt County known as Road 1007, Road 2043, Road 1009, Road 1011, Road 1012, Road 1013, Road 1015, Road 1017, Road 1018, Road 1020, Road 1019, Road 1018, Road 2042, Road 2043, Road 2044, Road 2045, Road 2046, and Road 1012, which are more specifically described as follows:

Width of Right of Way is a strip of land 60 feet in width, lying 30 feet on each side of the centerline as currently constructed. If additional area is needed for grading and maintenance, it will be addressed on a per case basis.

Commissioner Toavs stated that he also thought that the position should start for the 2023-24 school year and that we need this position to protect our kids. The position will be under the Sheriff's Office and Jason will need to figure out the logistics.

Commissioner Oelkers asked if the school wanted to get rid of the SRO position. Kim Hanks stated that the issue was that the SRO is really not a law enforcement officer and so if there was an issue, he was unable to do anything until law enforcement was present, which sometimes could be a lengthy wait. Jason stated the MOU would solve this problem and provide the school with a full-time officer.

Eileen Karge asked who should be communicating with HPDP and what do we do with the employee from June-August. Jason stated the communication could be handled by himself and Lawrence Hamilton. Kim Hanks stated that since summer school is in session from July to August that the SRO would continue to work as normal

Commissioner Toavs is hoping for a smooth transition from the school district to the county if the issues with the MOU can be resolved.

Bill Juve questioned if the annual salary included benefits. Yes, the total amount consists of the salary plus benefits.

A motion was made by Commissioner Macdonald to consider a friendly amendment to rework the MOU. Commissioner Toavs seconded. All in favor, motion to rework the MOU passed.

A motion was made by Commissioner Macdonald to reappoint Scott Toavs to the Weed District Board, seconded by Commissioner Toavs. Passed

A motion was made by Commissioner Macdonald to reappoint Gary Hanson to the Weed District Board, seconded by Commissioner Toavs. Passed

A motion was made by Commissioner Toavs to accept resignation from the Justice of the Peace employee Jerri Grimsrud, reluctantly seconded by Commissioner Macdonald. Passed
