- 2. An eligible County elected official/employee may receive the following:
 - a. Only one of the three meal allowances provided, if the travel was performed within the person's assigned travel shift; or
 - b. A maximum of two meal allowances if the travel begins before or was completed after the person's assigned travel shift and the travel did not exceed 24 hours.
- 3. A "travel shift" is defined as that period of time beginning one hour before person's regularly assigned shift and ending one hour after the person's assigned work shift.
- 4. To be eligible for a meal reimbursement while traveling on official business, the person must have been in a "travel status" for more than three (3) hours within the meal time frame and be a distance of at least 15 miles from headquarters or home, whichever is closer.
- 5. A receipt for meals is not necessary to obtain reimbursement.
- 6. If a meal is included in a convention registration fee or if a meal is paid for by a company or its employee(s), it cannot be included on a claim for reimbursement.
- 7. Mileage rate for the use of a car will be 67 cents per mile driven for business use for the first 1,000 miles. The rate for mileage over 1,000 miles is 64 cents per mile within each month.

- 5. Prior to taking final action on any matter of significant interest to the public, the chairman presiding commissioner of the Board will provide reasonable time for any person present to submit data or comments either orally or in writing regarding final action that may be taken by the Board;
- 6. The office of the Board of County Commissioners is open for business from 8:00 a.m. to 12:00 noon and 1:00 p.m. to 5:00 p.m. Monday through Friday. No notice will be given of routine matters or impromptu discussions with county employees, vendors or other citizens. All meetings of the County Commissioners are open to the public unless closed as provided by statute.

Commissioner Macdonald then stated that you have received a raise besides the cola. Cheryl mentioned that GIS and IT received a raise last year, they were moved to 92%. Commissioner Toavs asked if Mr. Vine has a wage request. Mr. Vine stated he would like to get what the head nurse is getting. Ms. Hansen stated that Mr. Vine will be very busy during this election with all the changes to elections. Mr. Vine explained that all county offices call him when it comes to addressing and his job is to make all elected officials look good. Mr. Vine stated he will train someone before he retires.

Mr. Lund stated he will reach out to Redtail, and they will reach out to Mrs. McNabb to get the agreement in place.

WHEREAS, 7-3-173(2) M.C.A. requires that the governing body shall call for an election, to be held on the primary election date, on the question of conducting a local government review and establishing a study commission; and

WHEREAS, the Roosevelt County Commission is the governing body of the County of Roosevelt.

NOW THEREFORE BE IT RESOLVED THAT:

1. The County of Roosevelt hereby calls for an election on the question of conducting a local government review and electing a study commission to be held at the Primary election on June 4, 2024.

- 2. If the voters decide in favor of conducting a local government review, a study commission comprised of three members shall be elected at the General election of November 5, 2024.
- 3. Pursuant to 7-3-175, M.C.A. the question of conducting a local government review shall be submitted to the electors in substantially the following form:

Vote for one:

[] FOR the review of the government of Roosevelt County and the establishment and funding, not to exceed 2 mills or approximately \$65,320.00, of a local government study commission consisting of 3 members to examine the government of Roosevelt County and submit recommendations on the government.

[] AGAINST the review of the government of Roosevelt County and the establishment and funding, not to exceed 2 mills or approximately \$65,320.00, of a local government study commission consisting of 3 members to examine the government of Roosevelt County and submit recommendations on the government.
