Gary: proposes city waving landfill fees and the city hires a contractor to do the work.

Chris: what is the hangup? Said he will talk to every taxpayer. No issue with using rural equipment in the city limits. County has helped before no issues. Rural residents use the city streets. Save the taxpayer money and have the city do it themselves. Need these places cleaned up for housing. Cleaning up 3 lots currently. 6 very bad properties right now.

Gordon: As the county takes over, they will clean up in a timely manner as they take it over. Moving forward to help all the cities. With the help of each city. Work with each community. Still contribute. Start all over with MOU. Couple more working sessions.

Gary: Decide after tax deed how many to clean up.

Chris: 1 year will not work. Biggest complaint he gets is when are the city and county going to work together. When are we actually going to start working together.

Gary: need to hire an independent contractor. Do not want to make them upset.

Chris: Do one of each. Inhouse and independent contractor.

Robert: Case by case basis. Must remember we are dealing with taxpayer dollars.

Chris: Scheduling in house can get it done much faster and can stretch the money way farther. Can do 4 instead of 1.

Robert: Whatever you do for 1 city you should do for the rest. Figure out how to get it all to work.

Tom: Down the road we will need to do for all cities.

Gary: We will have county equipment in every city and town in Roosevelt County. Taxpayers will start complaining about the equipment being in town and not out on the county roads.

Tom: Every city should equally contribute. But every city is a case-by-case basis. Each individual MOU.

Chris: Blanket MOU will not work. Need to get tax base back up.

Gordon: Move forward with the properties in the future. No properties from the past. Keep county and city separate.

Chris: What if county never takes over another property? Maybe minimum of 2 a year.

Gordon: This needs to all go in an MOU. Work together. This is a working session. Tom: Need to remember liability.

Juve: WP vs. Culbertson tax deed properties.

Gary: Have to wait until September to make any decisions when tax deeds come out.

Robert: Road Foreman and head of maintenance for city to figure out estimated amount of time/dollar amount/equipment/etc. that will be needed. Would like to see this proceed forward, due to liability.

Chris: Wolf Point has resources that we can outlet. County and city should not be separate. Taxpayers complain that county and city don't come together and work together more.

Robert: Wolf Point has access to the landfill that county can use. County has access to dirt/gravel/etc.

Chris: Wants the County to go over MOU and make whatever changes necessary in the commissioners' opinions.

Gary: Set up another meeting after we get a list of tax deeds at the end of month.

Chris: Wants the next meeting to be without him so they can focus without his opinion. He will come to next meeting after they have looked over MOU.

Robert: Consider hiring independent contractors.

Gary: Put it out to bid, and if no bids we can do it ourselves.
