WHEREAS, the Roosevelt County Commissioners are aware that on some portions of the foregoing described road that petitions, grants, easements or resolutions may have been filed in the past, and as consequence, these portions appear to have been declared County Roads. However, some portions appear not to have been previously the subject of road petitions; and

WHEREAS, the foregoing road has been laid out, constructed, and maintained with state or county funds, and it appears that persons using such road have long been under the belief that the entire length of such road is a county road; and

WHEREAS, the Montana Code Annotated 7-14-2101 states: (2) (a), following a public hearing, a board of county commissioners may accept by resolution a road that has not previously been considered a county road but that has been laid out, constructed, and maintained with state department of transportation or county funds. (b) A survey is not required of an existing county road that is accepted by resolution by a board of county commissioners.

WHEREAS, the Roosevelt County Board of Commissioners, after due notice, held a public hearing on the <u>27th</u> day of <u>February</u> 20<u>23</u>, to solicit public input as to the advisability of declaring the forgoing described road to a county road; and after receiving such input, the Roosevelt County Board of Commissioners believe that to declare such to be a county road would be in the public's interest.

NOW THEREFORE BE IT RESOLVED, that pursuant to Section 7-14-2101, Montana Code Annotated, the foregoing described road known as Road <u>1012</u> is hereby declared to be a public road and shall hereby continue to be used by the public.

Linda asked how many county roads have been closed? How many roads have been closed since the resolutions that are declaring the existence of a county road are being passed? How many of those resolutions have been changed? Linda stated it feels like they are being singled out. It was stated that none have been closed only resolutions have been made for public access.

Cody stated if this road is left open to the public and something happens to the current landowners, that could allow for possible development. Cody would appreciate it if it was not open. It was asked if someone get hurt on the road who is reliable? It was stated if it's a county road, county is liable. If the road is on private land, the landowner is liable.

Lane asked if there are any records of the county building the road. The gas tax map was mentioned.

Commissioner Toavs stated there is already a dead end/ private property sign on the gate. Doesn't see issue with abandoning road from gate east but not from mailbox. The county has graveled to the mailbox. Doesn't want to landlock anyone.

Lynn asked who would be landlocked? Cody has two access points to his land. Linda stated that if abandoned the road from mailbox on wouldn't landlock anyone.

Commissioner Macdonald mentioned that a road was abandoned in Bainville before he was Commissioner, and everything was ok until someone else took over the land and wouldn't let the neighbor go down the road to his farm. Abandoning a road creates a problem.

Tom stated in the early 60's-70's there used to be a road that goes to highway 2, that where they would access Fred Wix's place.
