Lynn stated he talked to Cody Maloney, and he was still in favor of the road abandonment but couldn't make it to tonight's meeting.

Linda asked why they were the commissioners against this road abandonment.

Commissioner Oelkers replied for future use, mineral development, and leasing, and that a lot of county roads go into houses. So, the county doesn't want to set a precedent.

Lane stated with no documentation how can you say it's a county road.

Lynn stated that he hopes the commissioner will seriously consider abandoning this road.

Darrell asked if the road was abandoned, and if an oil well moves in and needs a road can you declare the road a county road again. Commissioner Oelkers explains there is a procedure, and the process is the same as abandoning the road.

Commissioner Oelkers stated the road abandonment petition will be on next Tuesday's commissioner public meeting to vote on. Commissioner Oelkers adjourned the meeting.

Public Input on Sand Mine Permit

Asgard Resource will be the mining company.

Statten Sanders stated that the sand mine pays close to the same amount as a gravel pit. The land they are using is State land and they have the mineral lease for it. The lease is for seven years. They have done some test holes already with small equipment on the west edge of their lease, the sand averages about ten to fifteen feet deep. There is not enough sand and east side to justify mining. There is a wetland in that area, and they are still waiting for the report. They only work during the warm months and close in the middle of November. They will use water from the dry prairie rural water. Once the sand is processed it will sit for about three weeks to continue to dry before it gets hauled away to the old Bainville frac sand plant, which Asgard is leasing the building and they will not be using the rail. Some of the sand will be stocked piled at the site. They will mine twenty acres at a time and reclaim the ground from the material that is left in the settling pond. They will reclaim the section already mine and move on to the next section of the land. The sand is tested out of a company in Oklahoma. Gregg asked how they prevent the sand from blowing away. Statten stated that they take out the ultra-fines and put a sprinkler on top of the pile. The road to the site is a private road and Asgard will build up and maintain the road. Commissioner Oelkers stated that the Road Foreman asks that JMAC stay on highway 16 and highway 2 to Bainville when hauling sand to Bainville. Jerry stated that he has a grazing lease on the same land. Was advised to talk with the State. Also, an oil company has leases on the land and road. Statten stated that they wanted to make sure the community doesn't have any concerns with this project, and it will bring about a dozen job openings for the facility plus truck drivers to the area. Josh asked if Asgard has any power requirement for the project. Statten stated they prefer line power but will get a hold of Josh. Carly mentioned that the reclamation date is in 2032.
