A RESOLUTION REQUESTING AUTHORITY FOR DISTRIBUTION OF COUNTY MINIMUM ALLOCATION GRANTS FOR WATER AND SEWER INFRASTRUCTURE PROJECTS

Resolution

WHEREAS, Section 4 of Chapter 401 of the Montana Session Laws of 2021 through House Bill 632 Section 4 allocated the amount of \$150 million of the coronavirus state fiscal recovery funds to be used to provide minimum allocation grants for water and sewer infrastructure projects eligible for funding under the American Rescue Plan;

WHEREAS, the amount a local government is eligible to receive in water and sewer infrastructure grants under this section is in the same proportion and using the same ratios provided for in 15-70-101 (2)(b), (2)(c), and (3) giving County a minimum allocation of \$921,957.00;

WHEREAS, HB 632 Section 4 requires that a local government, submit an application for a qualifying water or sewer infrastructure project that complies with the uses authorized for the coronavirus state and fiscal funds and pledge matching funds;

WHEREAS, Montana's counties do not generally own or operate water and sewer infrastructure;

WHEREAS, grant funds must be applied for by November 1, 2022 and awarded or in a pending status by January 1, 2023;

WHEREAS, because counties generally do not own water and sewer infrastructure, HB 632 Section 4 allocated grant funds for qualifying water or sewer infrastructure projects within the counties for which it was allocated, but that any local government eligible to receive minimum allocation funds under HB 632 Section 4 could apply for and pledge matching funds for the county's proportion;

WHEREAS, Town of Culbertson is a local government as defined in HB 632 Section 4 and has committed to request the funds by November 1, 2022, if the county's allocation made eligible to them and the county has determined this to be a priority use of the allocated funds.

THEREFORE, NOW BE IT RESOLVED THAT:

1. County has determined that the proposed

Project is eligible as a minimum allocation project and is a high priority within the county and;

2. By this resolution, Roosevelt County requests the Department of Natural Resources and Conservation allow, through its developed application and distribution processes, the Town of Culbertson \$13,581.44 of its share of the allocated Minimum Allocation funds for the Town of Culbertson Highway 2 Water Main Replacement Project.

A RESOLUTION REQUESTING AUTHORITY FOR DISTRIBUTION OF COUNTY MINIMUM ALLOCATION GRANTS FOR WATER AND SEWER INFRASTRUCTURE PROJECTS

WHEREAS, Section 4 of Chapter 401 of the Montana Session Laws of 2021 through House Bill 632 Section 4 allocated the amount of \$150 million of the coronavirus state fiscal recovery funds to be used to provide minimum allocation grants for water and sewer infrastructure projects eligible for funding under the American Rescue Plan;

WHEREAS, the amount a local government is eligible to receive in water and sewer infrastructure grants under this section is in the same proportion and using the same ratios provided for in 15-70-101 (2)(b), (2)(c), and (3) giving County a minimum allocation of \$921,957.00;

WHEREAS, HB 632 Section 4 requires that a local government, submit an application for a qualifying water or sewer infrastructure project that complies with the uses authorized for the coronavirus state and fiscal funds and pledge matching funds;

WHEREAS, Montana's counties do not generally own or operate water and sewer infrastructure;

WHEREAS, grant funds must be applied for by November 1, 2022 and awarded or in a pending status by January 1, 2023;

WHEREAS, because counties generally do not own water and sewer infrastructure, HB 632 Section 4 allocated grant funds for qualifying water or sewer infrastructure projects within the counties for which it was allocated, but that any local government eligible to receive minimum allocation funds under HB 632 Section 4 could apply for and pledge matching funds for the county's proportion;

WHEREAS, Town of Bainville is a local government as defined in HB 632 Section 4 and has committed to request the funds by November 1, 2022, if the county's allocation made eligible to them and the county has determined this to be a priority use of the allocated funds.

#### THEREFORE, NOW BE IT RESOLVED THAT:

- 1. County has determined that the proposed Project is eligible as a minimum allocation project and is a high priority within the county and;
- 2. By this resolution, Roosevelt County requests the Department of Natural Resources and Conservation allow, through its developed application and distribution processes, the Town of Bainville \$130,795.00 of its share of the allocated Minimum Allocation funds for the Town of Bainville Water Main Replacement Project.

Resolution to correct resolution number 2022-20

#### RESOLUTION REGARDING ROOSEVELT COUNTY'S POLICY ON CATTLE GUARDS AND THE INSTALLATION OF CATTLE **GUARDS**

WHEREAS, there is a continuing need for stock control that is in conflict with open roads;

WHEREAS, stock control can be established across roads with the installation of cattle guards;

WHEREAS, Roosevelt County Road Department is not in the business of stock control;

WHEREAS, Roosevelt County's preference is to discourage installation of cattle guards due to herd provisions and assumed liability of having cattle on roadways;

#### NOW THEREFORE, BE IT RESOLVED BY THE ROOSEVELT COUNTY COMMISSIONERS OF ROOSEVELT COUNTY, MONTANA,

That the following policy is hereby adopted to establish the minimum standards for permitting the installation of cattle guards on Roosevelt County Roads:

- 1. The landowner or permittee will provide a map of affected area to Roosevelt County.
- 2. An approved encroachment permit will be required prior to installation.
- 3. Cattle guards shall be designed and installed to accommodate H-20 loadings with concrete footings. Pre-cast footings are allowed.
- 4. The minimum width of cattle guards shall be 24 feet and additional width will be required when indicated.
- 5. Failure to properly maintain the cattle guard in satisfactory condition will be justification for removal or filling in the guard.
- 6. Adequate drainage will be required for all cattle guard installations. It is the responsibility of the landowner or permittee to insure adequate drainage.
- 7. The landowner or permittee must get written consent of adjacent landowners. The landowner or permittee shall use the consent form approved by Roosevelt County.
- 8. Cattle guards and cement units shall be purchased by the landowner or permittee.
- 9. Installation of the cattle guard will be performed by Roosevelt County.
- 10. Roosevelt County shares no cost unless it is the replacement of a pre-existing unit specifically installed for the convenience for Roosevelt County and the landowner, i.e. water diversion on road re-construction.
- 11. Roosevelt County will perform inspection of cattle guards. If maintenance is required, Roosevelt County will complete the repairs and bill the beneficiary of the cattle guard, landowner, or permittee a fee of \$300.00 per clean up with one (1) free clean-up every five (5) years.
- 12. Roosevelt County shall not be responsible for maintenance or snow removal on cattle guards.
